

**NOTICE TO FORMER EMPLOYEES OF CLAIM AMOUNTS,  
CLAIM RESOLUTION PROCEDURES AND MOTION TO DISMISS  
DEBTOR'S CHAPTER 11 CASE**

**IN RE METROPARK USA, INC., CASE NO. 11-22866 (RDD), UNITED STATES  
BANKRUPTCY COURT, SOUTHERN DISTRICT OF NEW YORK**

On May 2, 2011 (the “**Petition Date**”), Metropark USA, Inc., (the “**Debtor**”) filed a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code (the “**Bankruptcy Code**”) in the United States Bankruptcy Court for the Southern District of New York (the “**Bankruptcy Court**”) assigned case no. 11-22866 (the “**Bankruptcy Case**”). The Debtor has liquidated all assets and has insufficient funds to propose a Chapter 11 plan.

**PLEASE TAKE NOTICE**, that on October 4, 2018, the Debtor filed a Motion to Dismiss the Debtor’s Bankruptcy Case Pursuant to Section 1112(b) of the Bankruptcy Code and for Related Relief (the “**Motion to Dismiss**”). **PLEASE TAKE FURTHER NOTICE**, that the Debtor will be making a *pro rata* distribution to former employees with priority claims.<sup>1</sup> Exhibit 1 attached to this Notice shows the amounts due to former employees as originally scheduled by the Debtor and the adjusted amount due after reduction for pre-petition wages already paid by the Debtor after the Petition Date. **Former Employees should review the “Amount Due” as shown on the last column on Exhibit 1.** This is the amount, if any, based upon the Debtor’s books and records, which the Debtor asserts is owed to former employees on account of allowed priority claims. *Former employees will not receive payment in full of the Amount Due. All distributions to former employees will be reduced by taxes and any other amounts required to be withheld.* In addition, based on the Debtor’s available cash only a *pro rata* distribution can be made on allowed priority claims (estimated to be eleven percent (11%)).

**Objection Procedures to Asserted Amounts Due**

(a) If you disagree with the Amount Due shown in the last column on Exhibit 1, or you are not listed and believe you have a valid claim entitled to priority under Section 507(a)(4) of the Bankruptcy Code, you **MUST FILE** in writing with the Bankruptcy Court an objection (an “**Amount Objection**”). To be considered a timely Amount Objection, an Amount Objection must be filed with the Bankruptcy Court and served on counsel for the Debtor, Courtney A. Schael, Esq., Ashford Schael LLC, 100 Quimby Street, Suite 1, Westfield, New Jersey 07090, Tel. 908-232-5566, Fax 908-728-3113, [cschael@AshfordNJLaw.com](mailto:cschael@AshfordNJLaw.com) with a copy to the Bankruptcy Court’s Chambers so as to be *actually received* by **December 3, 2018 at 5:00 p.m.** (prevailing Eastern Time) (the “**Objection Deadline**”).

(b) The Debtor and its professionals will attempt in good faith to resolve an Amount Objection with any party that timely files an Amount Objection on or before the Objection Deadline (an “**Objector**”). If such a resolution cannot be reached with an Objector, such Objector must appear (in person or by telephone) at the hearing on the Motion to Dismiss scheduled for **December 17, 2018, at 10:00 a.m.** (the “**Hearing**”) to prosecute an unresolved Amount Objection.

(c) An Amount Objection must contain the amount that the objecting party believes is due along with all appropriate documentation in support thereof. Unless you properly file and serve an Amount Objection, the amount utilized by the Debtor for distribution shall be the Amount Due set forth on Exhibit 1. *Failure to assert any amounts in excess of the Amount Due on Exhibit 1 shall constitute the waiver thereof and claims to such amounts shall be forever barred.*

**PLEASE TAKE FURTHER NOTICE**, that this Notice was mailed to the addresses on Exhibit 1. *If the address listed on Exhibit 1 is not your current address, prior to the Objection Deadline you must send your current address in writing to:* counsel for the Debtor, Courtney A. <sup>1</sup> For purposes of this Notice, a “priority claim” means allowed unsecured claims but only to the extent of up to \$11,725.00 for each individual or corporation, as the case may be, earned within 180 days before the date of the filing of the petition for (A) wages, salaries, or commissions, including vacation, severance, and sick leave pay earned by an individual or (B) sales commissions earned by an individual or by a corporation with only 1 employee, acting as an independent contractor in the sale of goods or services for the debtor in the ordinary course of the debtor’s business if, and only if, during the 12 months preceding that date, at least 75 percent of the amount that the individual or corporation by acting as an independent contractor in the sale of goods or services was earned from the debtor.

**PLEASE TAKE FURTHER NOTICE**, that by the Motion to Dismiss, the Debtor shall be requesting an Order from the Bankruptcy Court granting the following relief, following a hearing scheduled for December 17, 2018 at 10:00 am:<sup>2</sup>

**1. Dismissal.** The Debtor shall be requesting that the Bankruptcy Court dismiss the Chapter 11 Case pursuant to Section 1112 of the Bankruptcy Code.

**2. Distributions to Creditors.** After entry of an Order dismissing the Bankruptcy Case, the Debtor shall distribute funds first to administrative creditors holding allowed administrative expenses claims, including professionals of the estate. After all administrative expense claims have been paid in full, the remaining funds, less a reserve approved by the Court, shall be distributed *pro rata* to former employees holding claims entitled to priority under section 507(a)(4) of the Bankruptcy Code (“Priority Claims”).

**3. Proposed Distribution Procedures.** At the Hearing, the Debtor will also request approval for the following relief with respect to payments proposed to be paid on account of allowed priority claims: (a) that any payment that would otherwise be authorized to be paid in accordance with the Motion to Dismiss that would result in a payment of less than \$75.00 before reductions for taxes shall not be made; (b) that any distributed check(s) that has not been claimed and/or cashed within two (2) months from the date of such check(s), shall be deemed void; (c) that any funds that remain on hand after the two (2) month period shall be turned over to the Debtor and used, in the discretion of the Debtor, for any of the following: (i) for *pro rata* distribution to priority creditors, to the extent not otherwise paid in full, (ii) to pay any expenses that the Debtor or its professionals may incur with respect to the administration of the payments authorized to be paid, (iii) the filing of tax returns or the dissolution of the Debtor under applicable state law, or (iv) to be donated to a charity; and (d) that any claims of former employees that have not provided current addresses to the Debtor shall be disallowed and no distribution shall be made to such employee.

**4. Abandonment of Certain Property.** The Debtor will request authorization and approval to abandon certain assets of the estate that the Debtor has determined have inconsequential value to the estate. These assets include, potential claims and causes of action against the Committee and its Counsel relating to Avoidance Action litigation, claims against sale proceeds payable to secured creditors; and the destruction of the Debtor’s books and records.

**5. Preservation of Avoidance Actions Orders, Dissolution of Company and Exculpation.** The Debtor will request that transfers from Avoidance Actions be preserved, that the Debtor be dissolved after making distributions and inclusion of the following provision in the Order dismissing the Bankruptcy Case:

**From and after the date of this Order, the Debtor and its present or former directors, officers employees, members, attorneys, consultants, advisors and agents shall not have or incur any liability to any person, for any act taken or omitted to be taken in connection with or related to the formation, preparation, dissemination, implementation, confirmation or consummation of this Motion (other than an action in contravention of the Motion or the implementation of this Order) or any contract, instrument, release or agreement or document created or entered into, or any other act taken or omitted to be taken in connection with the Bankruptcy Case, the Motion or this Order; provided however that the foregoing shall not affect liability that otherwise would result from any such act or omission to the extent that such act or omission is determined to have constituted gross negligence or willful misconduct.**

**Objections to the Motion to Dismiss.** If you have an objection to the Motion to Dismiss, you also must file that objection, and serve Debtor’s Counsel **on or before December 10, 2018** (the “**Dismissal Objection**”). A Dismissal Objection must be in writing, must state the name and address of the objecting party and the nature of the claim or interest of such party, and must state with particularity the basis and nature of the Dismissal Objection.

**Adjournments of the Hearing.** The Hearing may be continued from time to time without further notice other than an announcement of the adjourned date(s) at the Hearing or as set forth on the electronic docket maintained by the Clerk of the Bankruptcy Court, and the proposed form of Order with respect to the Motion to Dismiss may be modified, if necessary, prior to, during or as a result of the Hearing, without further notice to interested parties.

<sup>2</sup> The summary of the terms of the Motion to Dismiss set forth in this Notice is solely intended for the benefit of former employees and is qualified by the Motion to Dismiss. In the event of any conflict between the terms set forth in this Notice and the Motion to Dismiss, the Motion to Dismiss will govern. Capitalized terms not defined herein have the meanings set forth in the Motion to Dismiss.
