**NOTICE OF HEARING AND OBJECTION DEADLINE**

**PLEASE TAKE NOTICE** that on November 12, 2021, BGBC Partners, LLP, accountants and financial advisors to Deborah J. Caruso, the chapter 7 trustee in this case (the “Trustee”), pursuant to the *Order Granting Trustee’s Motion for Authority to Establish Procedures for Interim Compensation and Reimbursement of Expenses for Professionals Effective as of February 1, 2017* (the “Interim Compensation Procedures Order”) [**Doc 1569**], filed its *Notice of Invoice for BGBC Partners, LLP’s Fees and Expenses for the Period of October 1, 2021 through October 31, 2021* [**Doc 4512**] (the “Notice of Invoice”).

**NOTICE IS GIVEN** that, pursuant to the Interim Compensation Procedures Order, any objection to the Notice of Invoice must be in writing and filed with the Bankruptcy Clerk by no later than **4:00 p.m.** (prevailing Eastern time) on **November 19, 2021**. Parties not represented by an attorney may deliver any written objection to the Notice of Invoice, as follows: (a) by U.S. mail, courier, overnight/express mail at Clerk, United States Bankruptcy Court, Re: *In re ITT Educational Services, Inc. et al.*, 116 U.S. Courthouse, 46 East Ohio Street, Indianapolis, IN 46204; or (b) by publicly accessible drop box available at the Indianapolis Division located at the New York Street and Pennsylvania Street entrance.

The objecting party must also serve a copy of the written objection upon the Trustee’s counsel, at Counsel for Trustee Deborah J. Caruso, Rubin & Levin, P.C., 135 N. Pennsylvania Street, Suite 1400, Indianapolis, IN 46204 (mtheisen@rubin-levin.net). **In the event an objection is NOT timely filed, the Trustee is authorized to pay 80.0% of the total fees and 100.0% of the total expenses requested in the Notice of Invoice, subject to the availability of funds as determined by the Trustee.**

**NOTICE IS FURTHER GIVEN** that all objections shall (i) specifically identify the time entries to which the objecting party objects, (ii) conspicuously state the nature of the objection, and (iii) identify the amount of fees or costs proposed to be paid pursuant to the Notice of Invoice to which the objection is made. If an objecting party objects to only a portion of the proposed compensation, then the Trustee is authorized to pay the amount of the compensation or expense reimbursement which is not challenged, subject to the availability of funds as determined by the Trustee.
