**ORDER SUSTAINING TRUSTEE’S 2ND OMNIBUS
OBJECTION TO CLAIMS PURSUANT TO BANKRUPTCY RULE 3007(d)(5)**

This matter is before the Court on the *Trustee’s 2nd Omnibus Objection to Claims Pursuant to Bankruptcy Rule 3007(d)(5) and Notice of Response Deadline* (the “2nd Omnibus Objection to Claims”) [Doc 53], filed by Deborah J. Caruso, the chapter 7 trustee in this case (the “Trustee”). Pursuant to Rule 3007(d)(5) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), the Trustee objected to those claims listed on Exhibit 1 to the 2nd Omnibus Objection to Claims on the grounds that the claims have been satisfied or released during the case in accordance with the Bankruptcy Code, applicable rules, or a court order.

The Court, having considered the 2nd Omnibus Objection to Claims and convened a hearing on June 23, 2021 at which the Trustee orally amended her 2nd Omnibus Objection to

Claims to withdraw her objection to Claim Nos. 127 and 166, and being otherwise duly advised in the premises, determines that the 2nd Omnibus Objection to Claims, as modified on the record at the hearing, should be, and hereby is, SUSTAINED. Accordingly,

IT IS THEREFORE ORDERED as follows:

1. The 2nd Omnibus Objection to Claims, as modified on the record at the hearing, is SUSTAINED.

2. The Trustee withdrew her objection to Claim Nos. 127 and 166. All other claims to which the Trustee objected pursuant to the 2nd Omnibus Objection to Claims are hereby disallowed in their entirety as indicated on Exhibit A, and in accordance with Bankruptcy Rule 3007(d)(5), on the grounds that such claims were satisfied or released during the case in accordance with the Bankruptcy Code, applicable rules, or a court order. The Trustee is hereby authorized to update the claims register accordingly.

3. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
