4           **PLEASE TAKE NOTICE** that, on September 15, 2017 (the “Petition Date”), Zetta Jet  
5 USA, Inc., a California corporation and the debtor and debtor in possession in the above-  
6 captioned Chapter 11 bankruptcy case (the “Debtor”), filed a voluntary petition under Chapter 11  
7 of 11 U.S.C. § *et seq.* (the “Bankruptcy Code”) with the United States Bankruptcy Court for the  
8 Central District of California – Los Angeles Division, commencing the above-captioned Chapter  
9 11 bankruptcy case.

10           **PLEASE TAKE FURTHER NOTICE** that, on September 19, 2017, the Debtor filed an  
11 emergency motion (the “Wage Motion”) seeking the entry of an order authorizing the Debtor to  
12 (1) pay pre-petition priority wages, including all applicable federal and state withholding taxes  
13 and payroll taxes (collectively, “Wages”), to its non-insider employees and independent  
14 contractors (collectively, “Employees,” and each, an “Employee”), provided that no Employee  
15 shall receive more than \$12,850 for such Wages; and (2) continue to honor the Debtor’s  
16 employment and benefit policies in the ordinary course of the Debtor’s business. The Debtor is  
17 not seeking authority pursuant to the Wage Motion to pay the pre-petition priority Wages of any  
18 employees who are “insiders” as defined in the Bankruptcy Code; approval to pay insider  
19 compensation will be sought pursuant to Notices of Setting Insider Compensation which will be  
20 filed with the Office of the United States Trustee.

21           **PLEASE TAKE FURTHER NOTICE** that an emergency hearing on the Wage Motion  
22 has been set on **September 20, 2017 at 2:00 p.m. in Courtroom 1575 located at 255 E.**  
23 **Temple Street, Los Angeles, California**, before the Honorable Sandra R. Klein, United States  
24 Bankruptcy Judge.

25           **PLEASE TAKE FURTHER NOTICE** that parties may appear by telephone at the  
26 hearing on the Wage Motion. Telephonic appearances may be arranged by contacting Chambers
