**AGREED ORDER ON DISTRIBUTION TRUSTEE'S OBJECTION TO
ADMINISTRATIVE CLAIM FILED BY VERIZON**

[Resolves Docket No. 1725]

ON THIS DATE the Court considered the Distribution Trustee's Objection to Administrative Claim filed by Verizon [Docket No. 1725] (the "**Objection**") filed by GlassRatner Advisory & Capital Group, LLC, as Trustee for the 4 West Distribution Trust (the "**Trustee**" of the "**Distribution Trust**") in the above-captioned case. The Court finds that the Trustee and Verizon (Subsidiaries of Verizon Communications, Inc.) ("**Verizon**") have reached an agreement to resolve the Objection. Based on the agreement between the parties, and having considered all other evidence presented, the Court finds that just cause exists for entry of the following Order.

IT IS THEREFORE ORDERED that the Objection is hereby **SUSTAINED** in part and **DENIED** in part.

IT IS FURTHER ORDERED that Proof of Claim No. 367 filed by Verizon on June 5, 2019, as an administrative expense claim in the amount of \$7,464.79 (the "**Claim**") is hereby reduced from \$7,464.79 to \$4,398.67, and that the Claim shall be **ALLOWED** as an administrative expense claim under 11 U.S.C. § 503(b) in the reduced amount of \$4,398.67.
