ORDER SUSTAINING DISTRIBUTION TRUSTEE'S OMNIBUS OBJECTION
TO SATISFIED PRIORITY TAX CLAIMS OF
TEXAS COMPTROLLER OF PUBLIC ACCOUNTS

ON THIS DATE the Court considered *The Distribution Trustee's Omnibus Objection to Satisfied Priority Tax Claims of Texas Comptroller of Public Accounts* [Docket No. 1707] (the "**Objection**") filed by GlassRatner Advisory & Capital Group, LLC, as Trustee for the 4 West Distribution Trust (the "**Trustee**" of the "**Distribution Trust**") in the above-captioned case. The Court finds that the Objection contains proof sufficient to overcome the presumption of validity imposed by Fed. R. Bankr.
