AGREED ORDER GRANTING MOTION FOR RELIEF FROM AUTOMATIC STAY

CAME ON for consideration the Motion for Relief from Automatic Stay (the “Motion”) filed by Bruce Clark, as Executor for the Estate of William Mason, Deceased (“Movant”). The Court, having considered the Motion, the Response, the arguments, and agreement of the parties, finds that Movant properly served the Motion and that the Motion should be, in all things, GRANTED. It is, therefore,

ORDERED that the Motion shall be, and the same hereby is, GRANTED.

ORDERED that the automatic stay shall be, and the same hereby is, terminated with respect to Debtors as to Movant, to permit Movant, his successors and/or assigns to take any all steps necessary to exercise any and all state law remedies and pursue litigation against Debtors in state court to the extent Debtors remain nominal defendants. Should Movant obtain judgment

for monetary damages against Debtors, Movant's recovery is strictly limited to recovery from any and all insurance policies insuring Debtors at the time of the loss **as set forth in the notice of claim dated July 13, 2017.**

ORDERED that enforcement of this Order shall not be stayed until the expiration of fourteen (14) days after entry of this order, but rather can be enforced upon entry and the requirements of Rule 4001(a)(3) are waived.
