**ORDER GRANTING THE MOTION OF THE  
LIQUIDATING TRUSTEE TO DISALLOW CLAIMS FOR  
FAILURE TO PROVIDE APPROPRIATE IRS TAX FORM(S)**

Upon the *Motion of the Liquidating Trustee to Disallow Claims for Failure to Provide Appropriate IRS Tax Form(s)*, dated April 20, 2020 (the “Motion”), seeking entry of an order disallowing and expunging in full the Noncompliant Claims listed on Exhibit 1 hereto; and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided to (i) the Office of the United States Trustee, (ii) all Noncompliant Claimants whose claims stand to be affected by the relief requested in the Motion, and (iii) all other parties who have timely filed requests for notice under Rule 2002; and it appearing that no other or further notice of the Motion need be provided; and the relief requested in the Motion being in the best interests of the Debtors’ estates and their creditors; and the Court having considered the Motion and any responses thereto; and upon all of

ORDERED that this Order is without prejudice to the Liquidating Trustee's rights and defenses, including, among other things, the right to further object to any of the Noncompliant Claims referenced on the Exhibit 1 hereto on any basis whatsoever; and it is further

ORDERED that this Court will retain jurisdiction to construe and enforce the terms of this Order.
