**CERTIFICATION OF COUNSEL REGARDING LIQUIDATING

1. The deadline to respond to the Objection was September 8, 2020 at 4:00 p.m. (ET) (the “Response Deadline”), and a hearing on the Objection is set for September 16, 2020 at 10:00 a.m. (ET). Attached to the Objection was a proposed form of order, together with the exhibits thereto (the “Original Proposed Order”), granting the Objection.

4. Following productive discussions with the Liquidating Trustee, Ms. Mayfield agreed to the treatment of her claim No. 440 as set forth in the Original Proposed Order.
5. The Liquidating Trustee resolved the response of Ms. Phillips by agreeing to withdraw the Objection with respect to Ms. Phillips’ claim No. 418 as set forth in the revised proposed order (the “Revised Proposed Order”) attached hereto as **Exhibit A**. A blackline comparing the Revised Proposed Order against the Original Proposed Order is attached hereto as **Exhibit B**.

WHEREFORE, the Liquidating Trustee respectfully requests that the Court enter the Revised Proposed Order at its earliest convenience.
