**DECLARATION OF CATHERINE NOWNES-WHITAKER REGARDING
THE SOLICITATION OF VOTES AND TABULATION OF BALLOTS CAST
ON THE THIRD AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION
PROPOSED BY USA GYMNASTICS AND THE ADDITIONAL TORT
CLAIMANTS' COMMITTEE OF SEXUAL ABUSE SURVIVORS**

I, Catherine Nownes-Whitaker, hereby declare:

1. I am the Chief Operating Officer at Omni Agent Solutions (“**Omni**”), the claims and balloting agent retained by USA Gymnastics (the “**Debtor**”) in the above-captioned chapter 11 case (the “**Chapter 11 Case**”). Omni’s offices are located at 5955 De Soto Avenue, Suite 100, Woodland Hills, California 91367.

2. I submit this declaration (the “**Declaration**”) with respect to the solicitation of votes and the tabulation of ballots cast on the *Third Amended Joint Chapter 11 Plan Of Reorganization Proposed By USA Gymnastics And The Additional Tort Claimants Committee Of Sexual Abuse Survivors* [Dkt. 1655] (as may be amended, supplemented, or modified from time to time, the “**Plan**”). Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, knowledge that I acquired from the Debtor or its counsel, and my review of relevant documents. I am authorized to submit this

Declaration on behalf of Omni. If I were called to testify, I could and would testify competently as to the facts set forth herein.

3. This Court authorized Omni's retention as the claims and noticing agent to the Debtor pursuant to the *Order Authorizing The Debtor And Debtor In Possession To Employ Omni Management Group, Inc. As Claims And Noticing Agent Pursuant To 28 U.S.C. § 156(c), Effective As Of The Petition Date* [Dkt. 63] (the "**Retention Order**"), and directed Omni to act as the Debtor's balloting agent pursuant to the *Order Approving The Disclosure Statement And Plan Confirmation Procedures* [Dkt. 1659] (the "**Disclosure Statement Order**").² Pursuant to the Retention Order and Disclosure Statement Order, Omni is authorized to assist the Debtor with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan.

4. The Disclosure Statement Order established procedures to solicit votes from, and tabulate Ballots submitted by, holders of claims entitled to vote on the Plan (the "**Solicitation and Voting Procedures**"). It is my understanding that, under the Plan and the Solicitation and Voting Procedures, only holders of claims in the following classes were entitled to vote to accept or reject the Plan (collectively, the "**Voting Classes**"):

6	Abuse Claims
7	USOPC Claim
8	Indemnification Claims
9	FCR Claim
10	Abuse Claims Filed After the Bar Date

5. Omni adhered to the Solicitation and Voting Procedures outlined in the Disclosure Statement Order and distributed Solicitation Packages to holders of claims in the Voting Classes. The Solicitation Packages included a creditor's Ballot for its respective Voting Class, the Plan, the Disclosure Statement, the Disclosure Statement Order (without exhibits), the Confirmation Hearing Notice, the Debtor's Cover Letter, the Survivors' Committee's Letter (for holders of Class 6 Abuse Claims), and a pre-addressed return envelope. A detailed description of Omni's service of Solicitation Packages is set forth in the affidavits of service Omni filed on the docket. (*See* Dkts. 1670, 1679, 1722, 1723, 1724, 1725, 1726, 1727, 1730, and 1731).

6. Following distribution of the Solicitation Packages, creditors submitted Ballots to vote on the plan, which Omni reviewed, determined the validity of, and tabulated. Each Ballot submitted to Omni was date-stamped, scanned (if submitted on paper), entered in Omni's voting database, matched to the creditor's filed or scheduled claim, and processed in accordance with the Solicitation and Voting Procedures.

7. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation and Voting Procedures, (b) executed by the relevant holder entitled to vote on the Plan (or such holder's authorized representative), (c) returned to Omni via an approved method of delivery set forth in the Solicitation and Voting Procedures, and (d) actually received by Omni no later than November 29, 2021.

8. The final tabulation of timely and properly completed Ballots is attached hereto as Exhibit A. As set forth on Exhibit A, valid Ballots were received in Class 5 (General Unsecured Claims), Class 6 (Abuse Claims), Class 8 (Indemnification Claims), Class 9 (the FCR Claim), and Class 10 (Abuse Claims Filed After the Bar Date), and all such Classes voted to accept the Plan. No Ballot was received on account of the single claim in Class 7 (the USOPC Claim).

9. Certain Ballots were excluded from the final tabulation in accordance with the terms of the Disclosure Statement Order and the Solicitation and Voting Procedures. The excluded Ballots, and the reason(s) for their exclusion, are identified on Exhibit A.

10. A report of all Class 5 Ballots that elected treatment as Class 4 General Unsecured Convenience Claims is attached hereto as Exhibit B.

I declare under penalty of perjury as provided in 28 U.S.C. § 1746 that the foregoing is true and correct according to the best of my knowledge, information, and belief.
