Additional Tort Claimants Committee Of Sexual Abuse Claimants; and upon consideration of the *Debtor's Objection To Application To Employ Gibbins Advisors, LLC* [Dkt. 944], filed by USA Gymnastics as debtor and debtor in possession, and the *Statement And Reservation Of Rights Of The United States Olympic And Paralympic Committee In Response To The Application To Employ Gibbins Advisors, LLC* [Dkt. 943], filed by the United States Olympic & Paralympic Committee; and argument by counsel for the parties at the March 9, 2020 telephonic hearing; and the Court finds that it has jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and after due deliberation and for the reasons stated on the record, the Court hereby determines that the Application should be DENIED.

IT IS HEREBY ORDERED:

1. The Application is denied.
2. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
