WITHDRAWAL OF EMERGENCY MOTION [DKT 1175]

The United States Olympic and Paralympic Committee (“USOPC”), by and through its undersigned counsel, and counsel for the Survivor Plaintiffs have resolved the issues raised in the USOPC’s Emergency Motion for (i) Partial Reconsideration of the Court’s Order on Pretrial Conference Requiring In-Person Depositions in Colorado and (ii) for order requiring that depositions be taken remotely (the “**Motion**”) [Dkt. 1175] by agreeing to hold the depositions of Morane Kerek, Rick Adams, and Scott Blackmun remotely.
