FINAL DECREE CLOSING CERTAIN CHAPTER 11 CASES

Pursuant to Section VIII. F. of the *Second Amended Joint Chapter 11 Plan of Liquidation of Lucky’s Market Parent Company, LLC and Its Debtor Affiliates* [Docket No. 1397] (the “**Plan**”) and the *Order Confirming Second Amended Joint Chapter 11 Plan of Liquidation of Lucky’s Market Parent Company, LLC and Its Debtor Affiliates* [Docket No. 1423] (the “**Confirmation Order**”); and the Court having found it has jurisdiction over this matter and that venue is proper in this district; and the Court having found that this matter is a core proceeding; and it appearing that proper and adequate notice has been given and that no other or further notice is required; and the Court having determined that the just cause for the relief granted herein exists; and after due deliberation thereon; and sufficient cause therefor; it is hereby ORDERED that:

are hereby closed; provided, however, that the chapter 11 case of the Liquidating Debtor, Lucky's Market Parent Company, LLC, Case No. 20-10166 (JTD), shall remain open until closed by further order of this Court.

2. The required monthly and quarterly reports for the Office of the United States Trustee have been submitted, and the Statutory Fees under 28 U.S.C. § 1930(a)(6) have been paid in full for the Substantively Consolidated Cases to be closed.


3. Entry of this final decree is without prejudice to the rights of the Liquidating Debtor or any party in interest to seek to reopen the Substantively Consolidated Cases for cause.

4. The Liquidating Debtor is authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Plan and Confirmation Order.

5. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry, notwithstanding Bankruptcy Rules 6004 (h), 7062, 9014, or otherwise.

6. The Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation, and/or enforcement of this Order.
