I've been unable to tell you all I want because I've had to put everything in writing and I can't type so I have to "pen" everything and it is very difficult. Besides the physical work, careful attention must be used to make sentences ^{UNDERSTANDABLE} ~~understandable~~ since you cannot edit anything. Sentence structure and making it come out right is what takes so long, since there is so much to say. I would be wrong to myself, as well as you, if I don't tell you about what happened in Seattle 30 something years ago since it still airs on television on the show, "Unsolved Mysteries", even recently.

I ask in advance that you excuse any corrections or misspellings since I am going to have to hurry and finish this and mail it to you, it being the original draft.

My last letter to you (-1-26-22), I made a copy of but did not share it with anyone whatsoever.

After the letter to you of 1-26, my housing problem suddenly stopped with them paying my rent, ~~that~~ I attributed to you,

and wanted to thank you but couldn't, because I didn't know if you did, for sure, or not. So when housing here did an about face, and went back to not paying and telling me I have to leave again, and heard it implied that you had listened to recorded calls and was angry and/or unhappy believing I lied/or mislead you, it fit.

When housing paid last month, Doctors at the V.A. Hospital were ~~too~~ angry ~~at~~ at me and 2 doctors stopped 2 different meds that are addictive and I've been struggling with withdrawls from no testosterone and losing my strength even more with delays for my suboxen, which is terrible withdrawls also. I thought this, was because you were trying to help me, It fit.

For years, my enemies arrange carefully thought out traps that lead to death eventually. "Effort" is what I want to show you in these incidents I write about. Lots of "effort" by lots of different people who often "repeat" the same strategy for their goals. You see it enough times that I have ~~to~~ been able to see it, being laughed at and heckled even, saying there is nothing I can do about it because I am so stupid.

My not arguing about being stupid prevents them from concealing things since there is no reason to. If I argued that

I wasn't stupid and proved it, then they would cooperatively outsmart me. Some things I have no or little power over and with the repeated crimes against me, my enemies control me and anything and everything they do is a ruse. I intend to show you that I did not lie to you and would never deliberately mislead you. I don't have to, your Honor. It just isn't necessary to exaggerate anything. I am trying to get you to help me and that can't be expected if I lie to you. I consider lying as behavior of mentally ill. I've always known that everything I convey for help is going to be discredited and challenged and so I am ready for it if I just have a platform to present it.

This letter to you is part of that platform I seek. I feel like I'm fighting to be heard, which guarantees me the help I've begged and fought for, but I'm the only person with a blindfold over my eyes and duct tape over my mouth, and no lawyer to help me. If I lose, I die, more or less.

If what was implied to me that anything I allege was wrong, my reply to that is that I don't want you to think that I am not compassionate because I very much am.

When I first called "Abused in Scouting" I could tell immediately that I was ~~a bragger~~

an undesirable client to them and began trying to lead the conversation towards their rejection of me as a client. I already know about talking to lawyers when they are an ally, ally, of those I oppose, doing myself a disservice. When it comes to being a 'mark', I can tell immediately and of course, back off. I never get to argue for myself orally, verbally, and anything going against me I will overcome the challenge if I can speak. It's too hard for me to print out lengthy written explanations that need history to even make sense. To follow what is being reviewed, I have to be allowed to defend what may initially appear to be, or rather sound, like something it is not when presented with a narrator that hasn't faced cross examination (especially when they are in the wrong). I've always included in all my letters to everybody, that I have never been interviewed even and have never made my case to anyone who even might help me and don't get to speak out in my own defense, ever. I would have success since I focus on what is verifiable. No way would I lie and jeopardize my very life, my mortality. I'm trying to have you see that these incidents I repeatedly struggle with began in 1975. The same ole things keep happening to me so I can see the pattern in them all.

If I correctly interpreted what was implied to me, then that would mean A.I.S. Shared a copy of my 1-26-22 letter to you, with my relatives and if so then they were already communicating prior. It was already known that I was fearful and had been asking for help and can see things based on my situation that someone else probably wouldn't. My goals and intentions are trying to show that they won't help me and not to injure any of my opposition, in any way. I just want to be helped, that's all. I have to overlook lots of petty but deliberate harassment across the board of things I'm constantly at odds with.

I've steadily maintained my appeal for help exactly the same from day one. The longer this has gone on, the more I learn. I had been all over the country already when I discovered Seattle. A commercial fishing hub for Alaska. Marinas all over with 25 cent showers and laundry rooms, perfect city if you live out of your car.

There were union halls for merchant seaman and it was possible to hitchhike rides to Alaska on fishing boats. It was my business to know which boats were going where and when. Working the truckstops as a lyper (load-unload), and household movers for cash upon completion. Day labor at

temp services was plentiful). I ended up staying there about 8 years, (I think). I knew that I should be unpredictable regarding my sleep and was careful. My entire life has been a search to find a place to live where I could survive and not have someone looking for me be in a position to harm me while I sleep.

Since I was both working and looking for work, I met other people in similar situations as me including being homeless. In a car, I ~~so~~ could go all over the county.

Building over time, more and more people began approaching me about this Ballard lumber yard. Looking for ways to get to the waterfront the road to the lumber yard was a dead end, I had discovered, but I personally had no interest towards the place because I am a welder (steel) but am not at all - any type of carpenter.

I've never been a drinker even though the V.A. lists me as an alcoholic. I can drink 50 cent watered down beers at the bars near the waterfront socializing with people I had worked with for example.

Whether the northside or south of Seattle, people out of nowhere were telling me it was a great place to sleep in the car or I should go to this Ballard lumber yard for a job. Being in so many different

places (moving around), enemies, who I had thought of as work buddies had a change of attitude towards me. I could not escape the topic of discussion was me, where I slept in my car and I should go to Ballard Lumber yard. They overplayed their hand without realizing it, flooding me with the same thing, working or sleeping at the Ballard Lumber yard.

Realizing something was wrong, I took a job I didn't really want, on a commercial fishing Catcher - Processor that carried a large crew and was hard work with low pay. I left my car at long term parking at Sea-Tac Airport and flew to Anchorage, Alaska (where I bought a ~~non-resident~~ non-resident commercial crew member fishing license for 90 dollars), then flew from Anchorage to Dutch Harbor - Unalaska in the Aleutian Islands, where I joined the fishing vessel "Bering Enterprise" and went to the Gulf of Alaska and the Bering Sea, fishing.

This was the days before cell phones and the internet. So marshalling this many people, it was a real feat. They would of had to make a lot of effort to reach this many people to all do the same thing, it was my private horror and I was all alone. The tactic that had always served me well was to run. Which is exactly what I did and at just the right time too, because when they launched

their well thought out, carefully arranged and planned out attack on me, I had just a couple of days earlier, left the state and was in one of the most remote places on earth and in the ocean, at sea, aboard the fishing vessel "Bearing Enterprise".

I would do things differently every day that I could, so I would more or less, disappear regularly, hiding my whereabouts since I lived and slept in my car. So when my enemies arsoned the Ballard Lumber yard and burned it to the ground in a huge fire, they were absolutely positive that I was not far away since I was homeless and lived in my car.

Since a small army of pre-positioned "witnesses" claimed that I started the fire and they saw me, my car, details, etc, they were a little disillusioned when they couldn't find me, so it began the manhunt. It was a done deal that I was guilty and all they had to do was locate me and arrest me. They could of killed me saying I was a bad guy, eliminating any chance of me revealing the truth.

When they finally found me, the trail shows I left and couldn't of possibly done it. The lead investigator was still determined to stick this on me when he knew that I was innocent. It would take someone with the

understanding of, and experience with, URBAN LOGISTICS, to be able to co-ordinate this entire attack. And like other failed attacks on me I saw anger in the faces when they are told about it. This all took lots of effort. Lots!.

As it became clear that I escaped the frame-up, supposed witnesses disappeared, leaving just ~~for~~ one or two who describe me, only. All the army of witnesses disappeared.

When the lead investigator located me, he went to Dutch Harbor where it was demanded that the boat come back because of me. After failing to get the Captain of the boat to go along with a lie, they began threatening the captain that he better say I wasn't there, but he refused. As a consolation to them, he fired me and refused to pay me. The company, Bering Enterprise Limited, lists me as an employee paid only one dollar but filed me as having been there. I'm sure that this was done on purpose.

When I returned to Sea-Tac airport, my car was in a different space and someone had been driving it and the most important point about it was the lame lies of those working at the long term parking lot making me think the only person they would cover for would be the cops. My car was rifled and damaged. They were desperate to find something, anything, so they could justify arresting me. The

investigators passed along slander and character assassination to the captain of the Bering Enterprise so that everyone hated me immediately. What that says, is that the frame-up they were doing was just like everything else which is that there is a different motive. They knew that I didn't start the fire and hated me for a different pre-existing reason. And that reason is as fraudulent as all the others leading to the real reason, a mark.

I was still a young man in my 20's when this happened. The unsolved mystery is that there never was a person and that those who identified me are the ones that started the fire. Based on what happened, it was made clear in Dutch Harbor that the Cops were the ones who put all this together, and were determined to put me in prison where I would be killed (or do it themselves).

I continually point out that if I was a bad person, no frame-up would be needed. Many get caught lying, oh, but this time they are telling the truth, (NOT). It was arranged and decided that I would be guilty, and when they learned that they couldn't, they just about threw a fit. (they had worked so hard to see this happen), and was angry and throwing all their weight around driven by hate, trying to get the boat to lie about my alibi. A big deal.

When I finally got back to Seattle, I had no idea that there had been a fire and so surprised to hear that I didn't know, they gasped about eyewitnesses who saw me, evaporated, but were originally there. So I heard what happened and bet it was probably on T.V., too. I knew the cops were out to get me but I didn't know why. I got off the boat and the boat left, going back to sea again. And I was stuck on a remote island with criminals who were after me, angry because their plan didn't work out. So I called the Dutch Harbor cops to keep the peace from those wanting to arrest me for a fire that they set. I couldn't of dreamed this up in a million years. Just like the red truck story. Fortunately for me, the Unsolved Mysteries helps me document one of many attacks on me.

Anymore, I know right away when there is 2 consences that I am an enemy. I've had to live with this all my life. Any misconceptions about the danger I face were reaffirmed with Ballard Lumber yard in Seattle. It is not a good feeling to know that so many people are out to get you. I realize that my enemies can attack me because I am homeless and therefore in the public eye, my

whole life almost (40 yrs.). After this incident, it was clear that I was in trouble no matter where I went. (In my 20's - still young)

I know right away when someone sides with those bent on destroying me. I see, hear and perceive things other people do not. I have to, I don't have a choice. If anything mentioned to me negative, just like in my last letter that I considered them saying regular mail a threat, I know unless they say they want to help me, which hasn't happened (ever) they are identifying themselves as thugs. When the context is life or death, I read between the lines with the best of them (at this). I've learned to feel an atmosphere when I'm talked down to, that I am an enemy. Leaving me with where I am I going to go? What am I going to do? All I have ever been able to do is run and when I stop, be ready to run again. I currently have been unable to keep a vehicle here where I live (theft or destroy).

I saw a dramatic change about the time my letter to you of 1-26 would of reached my enemies. I carefully word my letters just for this reason. So I can't really say what I want to. Experience has shown me that it can be a very bad idea!

Your Honor, I don't suppose to know if someone does or does not do anything, but it wasn't my idea and my enemies threats often materialize, so I just want to reassure you that my pleas for help are sincere and my enemies and I have an understood communication of threats. Nothing from them is innocent, nothing. I have little choice in my view towards those who declare that they are against me.

I've done well to be alive and I cannot think of anything that anybody (including myself) could do with this kind of problem.

I'm cornered, my cellphone was stolen and taken over and erase my history and control my email electronically, signing documents that I do not ever sign electronically. They tried to steal my vote and do not represent me your honor (A.I.S.).

I've never had a life, please spare my life, please help me.
