**CERTAIN INSURERS' STATUS UPDATE IN ADVANCE OF  
THE JANUARY 18, 2022 HEARING [D.I. 8300]**

The Certain Insurers<sup>1</sup> file this response (“Certain Insurers’ Response”) to the status report filed by the Official Committee of Tort Claimants (“TCC Status Report”) [D.I. 8190] and to the ensuing Debtors Response (“Debtors’ Response”) [D.I. 8234].

1. While the Certain Insurers recognize the importance of the voting issues raised by the TCC and addressed in the Debtors’ response, the Certain Insurers also have been abiding by the Court’s instruction to bring discovery issues before it promptly so that the Court may timely address such issues. Since the Court issued the updated Confirmation Scheduling Order [7996], the parties have worked constructively to address the substantial discovery, including significant deposition discovery, that remains to be completed prior to the January 28, 2022 discovery cutoff and in advance of the February 22, 2022 plan confirmation hearing. It is clear, however, that an unreasonable pile up of depositions in the last week of discovery is again imminent. The Certain Insurers seek to address this issue with the Court at the January 18 status conference.

2. To put the matter in perspective, the Debtors, TCC, Pfau/Zalkin and the Certain

Insurers are currently working to schedule over the remaining 14 days (including weekends) depositions of the more than 20 expert witness who have served reports and will testify at the plan confirmation hearing. The Debtors and the TCC have also noticed more than 20 depositions in connection with voting discovery. Additional depositions have been noticed by the TCC and the Roman Catholic Ad Hoc Committee regarding recent announced settlements. The Certain Insurers are also scheduling the depositions concerning plan supplement issues, including regarding the Settlement Trust Advisory Committee nominees, as well as the depositions ordered by the Court of the Coalition-aligned law firms concerning claims generation practices and the filing by those firms of attorney-signed proofs of claims. In short, although the parties have worked diligently, more than 50 depositions remain to be taken to complete discovery before the end of this month. The Certain Insurers would welcome the Court's guidance in resolving certain issues that are leading to the deposition pile-up.

3. The latest addition to the deposition pile up results from the now twice-delayed deposition of Ken Rothweiler, a STAC nominee. Mr. Rothweiler was initially scheduled to be deposed on Thursday, January 13. On January 8, the Certain Insurers learned from Mr. Rothweiler's counsel about a mediation session being conducted in this matter, and that the date for Mr. Rothweiler's deposition would need to be rescheduled as a result. Mr. Rothweiler's deposition was rescheduled for Monday, January 17. Today, Mr. Rothweiler's counsel asserted that the deposition would again have to be rescheduled as a result of mediation. This mediation, however, is not even scheduled to occur on Monday, January 17. While the Certain Insurers are mindful of the importance of mediation generally and of its particular role in this matter, unwarranted discovery delays such as this one simply compound what is already an impossible, and prejudicial, discovery crunch.

4. Additional discovery issues are likely to continue to slow progress in this matter. Although the Certain Insurers worked in good faith before, during, and after the holidays to negotiate the production of documents and depositions from the Coalition-aligned law firms, we fear that intractable disputes remain regarding relevance and privilege issues. The Certain Insurers are continuing their efforts to resolve these issues, but will request guidance from the Court at the upcoming status conference if they cannot be resolved.

#### **CONCLUSION**

The Certain Insurers look forward to discussing these issues with the Court on January 18, 2022.
