PCVA CLAIMANTS' JOINDER TO STIPULATION REGARDING PRELIMINARY INJUNCTION

The Claimants represented by Pfau Cochran Vertetis Amala PLLC (the "PCVA Claimants"), including Claimants Nos. 4480, 16251, and 42705, by and through their undersigned counsel, cautiously join and support the stipulation reached between the Tort Claimants Committee ("TCC") and the Debtors regarding BSA's Motion to Extend Preliminary Injunction Pursuant to 11 U.S.C. §§ 105(a) and 362 (Dkt. No. 145). The PCVA Claimants file this joinder to explain why they support the stipulation, and to ensure the record reflects why some of the PCVA Claimants may need to seek additional relief if the stipulation is ultimately not productive. This joinder relies upon the contemporaneously filed Declaration of Jason P. Amala in Support of PCVA Claimants' Joinder to Stipulation Regarding Preliminary Injunction ("Amala Decl.").

The PCVA Claimants support the stipulation because it requires the Debtors and local councils to provide certain records, including rosters and charters, that may help the PCVA Claimants identify and/or confirm 1) the local council who was responsible for their individual Scouting unit

(e.g., Boy Scout Troop or Cub Scout Pack), and 2) the chartering organization who sponsored their individual Scouting unit. In the event the Debtors and local councils are unable to provide those records, the stipulation allows a PCVA Claimant to ask the Court for permission to pursue additional discovery to assist the PCVA Claimant in identifying and/or confirming the correct local council and/or chartering organization. Amala Decl., at ¶ 4.

The relief afforded by the stipulation is critically important to the PCVA Claimants because (1) some of them do not know or recall the name of the chartering organization who sponsored their Scouting unit, (2) some of them are not certain they have identified the correct local council who was responsible for their individual Scouting unit, 3) some of them are not certain they have identified the correct chartering organization who sponsored their Scouting unit, but (4) all PCVA Claimants must timely file a lawsuit against the correct local council and chartering organization in order to preserve the viability of their claim, particularly with regard to the statute of limitations. Amala Decl., at ¶ 5.

As the Court and all parties are aware, neither the automatic stay nor the preliminary injunction toll or otherwise protect an individual Claimant's statute of limitations as to a local council or chartering organization. To the contrary, the preliminary injunction (and the proof of claim form) made clear that Claimants must take separate steps to protect any claim(s) they may have against non-Debtor entities, including local councils and chartering organizations. While the preliminary injunction allows the PCVA Claimants to file lawsuits against local councils and chartering organizations, it does not allow them to pursue discovery so they can confirm they have identified the correct local council and the correct chartering organization. Amala Decl., at ¶ 6.

While most of the PCVA Claimants believe they have identified the correct local council, many of the PCVA Claimants have *not* named a chartering organization because they do not know the name of the correct chartering organization. For example, out of approximately 137 PCVA Claimants who have filed, or will file, state court lawsuits in New York before its "window" closes

in mid-August 2021, approximately 25 of them have not named, and cannot name, a chartering organization because they do not know the name of the chartering organization who sponsored their individual Scouting unit. Similarly, out of approximately 62 PCVA Claimants who have filed, or will file, state court lawsuits in New Jersey before its "window" closes on December 1, 2021, approximately 13 of them have not named, and cannot name, a chartering organization because they do not know the name of the chartering organization who sponsored their individual Scouting unit. Amala Decl., at ¶ 7.

The claims filed by PCVA Claimant Nos. 4480, 16251, and 42705 illustrate the concern and why the PCVA Claimants (cautiously) support the stipulation. Amala Decl., Exs. 1-3.

For example, Claimant No. 4480 was sexually abused in North Carolina by an assistant Scout leader in his Scouting unit, Timothy Tilley. Amala Decl., Ex. 1, at 7. After the first instance of sexual abuse, Claimant No. 4480 reported the sexual abuse to his Scout leader. *Id.* at 10. In response, the Scout leader told Claimant No. 4480 that "it was probably sleep actions that were harmless and to just forget about it because it probably meant nothing." *Id.* at 10-11. After the Scout leader failed to protect Claimant No. 4480, Tilley continued sexually abusing Claimant No. 4480 until Claimant No. 4480 eventually dropped out of Scouting. *Id.* at 11.

North Carolina has suspended its civil statute of limitations for child sexual abuse until December 31, 2021. N.C. Gen. Stat. § 1-52. Under the foregoing facts, Claimant No. 4480 likely has a claim against the chartering organization for his Scouting unit because the Scout leader who ignored his complaint was likely an agent of the chartering organization and the organization was likely responsible for protecting Claimant No. 4480 and other children from foreseeable harm. Amala Decl., at ¶ 8. Unfortunately, Claimant No. 4480 does not recall the organization that sponsored his Scouting unit so he is currently unable to file a claim against that organization in North Carolina before its "window" closes later this year. Amala Decl., Ex. 1, at 8.

On the other hand, Claimant No. 4480's proof of claim includes information that should allow the Debtors and/or the relevant local council to identify the chartering organization of his Scouting unit, including his Scouting unit number, the physical location of his Scouting unit, and the years he was involved in Scouting. Amala Decl., Ex. 1, at 5-8. If the Debtors and/or the relevant local council are unable to help Claimant No. 4480 identify the correct chartering organization, Claimant No. 4480 will need to ask the Court for permission to pursue other discovery to find the missing information. Amala Decl., at ¶ 8.

Another example is Claimant No. 16251, who was sexually abused in New Jersey by a Scout leader in his Scouting unit, John Hollender, Jr. Amala Decl., Ex. 2, at 6. During the first instance of sexual abuse, other Scout leaders and adult volunteers in Claimant No. 16251's Scouting unit witnessed Hollender sexually abusing Claimant No. 16251 and other youth Scout members. *Id.* at 10-11. However, none of the Scout leaders or adult volunteers stopped or reported the sexual abuse. *Id.* As a result, Hollender continued sexually abusing Claimant No. 16251. *Id.* at 9-10.

New Jersey has suspended the civil statute of limitations for child sexual abuse until December 1, 2021. NJ Stat Ann 2A:14-2b. Under the foregoing facts, Claimant No. 16251 likely has a claim against the chartering organization for his Scouting unit because the Scout leaders and adult volunteers who ignored his abuse were likely agents of the chartering organization and the organization was likely responsible for protecting Claimant No. 16251 and other children from foreseeable harm. Amala Decl., at ¶ 9. Unfortunately, Claimant No. 16251 does not recall the organization that sponsored his Scouting unit so he is currently unable to file a claim against that organization in New Jersey before its "window" closes later this year. Amala Decl., Ex. 2, at 7.

It is worth pointing-out that Claimant No. 16251 recalls that his Scouting unit met at the Woodlynne Log Cabin in Woodlynne, New Jersey, but he does not recall the entity that owned and operated the Woodlynne Log Cabin at the time of the abuse. Amala Decl., Ex. 2, at 7. Rather than guess, and risk guessing wrong, Claimant No. 16251's proof of claim includes information that

should allow the Debtors and/or the relevant local council to identify the chartering organization of his Scouting unit, including his Scouting unit number, the physical location of his Scouting unit, and the years he was involved in Scouting. Amala Decl., Ex. 2, at 5-7. If the Debtors and/or the relevant local council are unable to help Claimant No. 16251 identify the correct chartering organization, Claimant No. 16251 will need to ask the Court for permission to pursue other discovery to find the missing information. Amala Decl., at ¶ 9.

A final example is Claimant No. 42705, who was sexually abused in New York by a camp official at Camp Keowa. Amala Decl., Ex. 3, at 6. After the first instance of sexual abuse, Claimant No. 42705 reported the sexual abuse to the Scout leader for his Scouting unit. *Id.* at 11. In response, his Scout leader did not take any action to protect Claimant No. 42705, including reporting the abuse so that the camp official could be removed from Camp Keowa and/or removed from Scouting. *Id.* As a result, the camp official continued sexually abusing Claimant No. 42705 at Camp Keowa. *Id.*

New York has suspended the civil statute of limitations for child sexual abuse until August 14, 2021. N.Y. C.P.L.R. 214-g. Under the foregoing facts, Claimant No. 42705 likely has a claim against the chartering organization for his Scouting unit because the Scout leader who ignored his complaint was likely an agent of the chartering organization and the organization was likely responsible for protecting Claimant No. 42705 and other children from foreseeable harm. Amala Decl., at ¶ 10. Unfortunately, Claimant No. 42705 does not recall the organization that sponsored his Scouting unit so he is currently unable to file a claim against that organization in New York before its "window" closes later this year. Amala Decl., Ex. 3, at 8.

On the other hand, Claimant No. 42705's proof of claim includes information that should allow the Debtors and/or the relevant local council to identify the chartering organization of his Scouting unit, including his Scouting unit number, the physical location of his Scouting unit, and the years he was involved in Scouting. Amala Decl., Ex. 3, at 5-8. If the Debtors and/or the relevant local council are unable to help Claimant No. 42705 identify the correct chartering organization,

Claimant No. 42705 will need to ask the Court for permission to pursue other discovery to find the missing information. Amala Decl., at ¶ 10.

As noted above, most of the PCVA Claimants believe they have identified the correct local council based on the geographic location of their Scouting unit or where the abuse occurred, but without discovery they have no way of independently confirming they have identified the correct local council. While this concern may be resolved if all of the local councils participate in the bankruptcy, the prospect of such a resolution does nothing to protect the legal rights of the PCVA Claimants, particularly with regard to the statute of limitations. For example, if a PCVA Claimant has identified the wrong New York local council in their New York lawsuit, and if the correct New York local council does not participate in the bankruptcy, the correct local council can try to object to the claim as untimely if it is not filed before the New York "window" closes in mid-August 2021. Amala Decl., at ¶ 11.

The PCVA Claimants support the stipulation because it is a first step toward helping them ensure that they have each identified the correct local council and/or chartering sponsoring organization. Not only are the PCVA Claimants entitled to this information so they can protect their legal rights as to all such entities, but this process would seem to be important to the Debtors, the local councils, and the chartering organizations to the extent the Debtors have proposed a plan that would allow local councils and chartering organizations to obtain channeling injunctions. Not only do the PCVA Claimants and others presumably have a right to know which of their claims may be released, but all parties presumably have an interest in making sure 1) any released entity makes an appropriate contribution for the release, 2) the insurance carriers make an appropriate contribution for any release of their insureds, 3) all liable parties have an opportunity to make an appropriate contribution for a release, 4) all available insurance policies are triggered, which generally requires that an insurer be presented with a claim that identifies one or more of its insureds, and 5) the Debtors'

plan can be confirmed because it satisfies the "best interests" test as to all parties who are released.

Amala Decl., at ¶ 12.

For example, it appears each local council maintained its own insurance for a long period of

time, and given the dates of those policies, it appears most of the policies do not have aggregate

limits. In order to negotiate with the insurer(s) who sold those "council only" policies, the insurers

presumably need to know the number of claims that trigger each policy. The same is true for any

separate insurance policy maintained by a chartering organization, and the same is presumably true

for any policy that named a local council or chartering organization as additional insured. In addition

to insurance, many of these entities have significant assets – not only do many of the councils

publicly report tens of millions of dollars in assets, but many of the chartering organizations have

significant wealth, like the Mormon Church. The Debtors have proposed a plan that provides an

opportunity for these entities to participate in their bankruptcy, but it is unclear how such

participation can happen until each entity (and their insurer(s)) know how many claims they are

facing and what they will need to contribute in order to obtain a channeling injunction. Amala Decl.,

at ¶ 13.

The PCVA Claimants cautiously support the stipulation because it is a step in the right

direction in terms of ensuring they are able to take steps to protect their legal rights as to all entities

who may be liable for the sexual abuse they suffered.

A true and accurate copy of Claimant No. 42705's proof of claim is attached as **Exhibit 3**.

Please carefully read the following instructions included with this SEXUAL ABUSE SURVIVOR PROOF OF CLAIM and complete ALL applicable questions to the extent of your knowledge or recollection. If you do not know the answer to an open-ended question, you can write "I don't recall" or "I don't know." If a question does not apply, please write "N/A." If you are completing this form in hard copy, please write or type clearly using blue or black ink.

The Sexual Abuse Survivor Proof of Claim must be delivered to Omni Agent Solutions, the Courtapproved claims and noticing agent (the "Claims Agent"), by either:

- (i) Hand delivery, first class mail, or courier the *original* proof of claim to: BSA Abuse Claims Processing, c/o Omni Agent Solutions, 5955 De Soto Ave., Suite 100, Woodland Hills, CA 91367, so that it is *received* on or before **November 16, 2020 at 5:00 p.m.** (Eastern Time);² or
- (ii) Electronically using the interface available at: www.OfficialBSAClaims.com on or before November 16, 2020 at 5:00 p.m. (Eastern Time).

Sexual Abuse Survivor Proofs of Claim sent by email or facsimile transmission will not be accepted.

"You" and/or "Sexual Abuse Survivor" refers to the person asserting a Sexual Abuse Claim against the Boy Scouts of America ("BSA") related to the Sexual Abuse Survivor's sexual abuse. For this claim to be valid, the Sexual Abuse Survivor must sign this form. If the Sexual Abuse Survivor is deceased or incapacitated, the form must be signed by the Sexual Abuse Survivor's representative or the attorney for the Sexual Abuse Survivor's estate. If the Sexual Abuse Survivor is a minor, the form must be signed by the survivor's parent or legal guardian or attorney. Any Sexual Abuse Survivor Proof of Claim signed by a representative or legal guardian must attach documentation establishing such person's authority to sign the claim for the Sexual Abuse Survivor.

Who Is a Sexual Abuse Survivor?

¹ The Debtors in these chapter 11 cases, together with the last four digits of each Debtor's federal tax identification number, are as follows: Boy Scouts of America (6300) and Delaware BSA, LLC (4311). The Debtors' mailing address is 1325 West Walnut Hill Lane, Irving, Texas 75038.

² If you are mailing your Sexual Abuse Survivor Proof of Claim, do not attach original documents with your Sexual Abuse Survivor Proof of Claim.

For purposes of this Sexual Abuse Survivor Proof of Claim, the term **Sexual Abuse Survivor** refers to a person who was sexually abused *before* turning eighteen (18) years of age.

Who Should File a Sexual Abuse Survivor Proof of Claim?

This Sexual Abuse Survivor Proof of Claim is only for people who were sexually abused before turning eighteen (18) years of age and where the sexual abuse (defined below) occurred on or before February 18, 2020. This Sexual Abuse Survivor Proof of Claim is the way you assert an unsecured claim against BSA seeking damages based on Scouting-related sexual abuse. Any person asserting a claim based on anything other than childhood sexual abuse should use the General Proof of Claim form (official bankruptcy form 410).

What Is Sexual Abuse?

For the purposes of this Sexual Abuse Survivor Proof of Claim, **sexual abuse** means, with respect to a child under the age of eighteen (18) at the time of the sexual abuse, sexual conduct or misconduct, sexual abuse or molestation, sexual exploitation, sexual touching, sexualized interaction, sexual comments about a person's body, or other verbal or non-verbal behaviors that facilitated, contributed to, or led up to abuse, regardless of whether or not such behavior was itself sexual or against the law, and regardless of whether the child thought the behavior was sexual abuse at the time. Sexual abuse includes behavior between a child and an adult and between a child and another child, in each instance without regard to whether such activity involved explicit force, whether such activity involved genital or other physical contact, and whether the child associated the abuse with any physical, psychological, or emotional harm. It involves behaviors including penetration or fondling of the child's body, other body-on-body contact, or non-contact, behaviors such as observing or making images of a child's naked body, showing or making pornography, or having children behave in sexual behavior as a group.



was a "police move" to subdue criminals. He would squeeze our genitals and hold onto them
really hard. I withdrew from the wrestling activity but some of the Scouts proceeded. During
this gathering I remember Tilley showed us all sorts of drugs that he said he obtained from the
police cases he handled and used to train dogs. He had cocaine, meth, and other drugs. He asked
me if I wanted to try any drugs, but I refused.
Later that night, the abuse continued. Tilley drove the other Scouts home but convinced me that
I needed to stay the night because he didn't have time to drive to my side of town. We were all
getting up early the next morning to go swimming, and he somehow convinced me that it made
sense to stay at his house. I assumed I would be sleeping on the couch, but he convinced me to
sleep in his bed. I slept on the side of the bed that was blocked by the wall. Tilley slept on the
other side. He kept sliding closer and closer to me during the night. He eventually forcefully
pulled off my pants. I then realize he had an erection when he started forcefully rubbing his
erect penis against me until he ejaculated. He was trying to kiss me during while he was "dry
humping" me until he ejaculated. It was disgusting and humiliating.
Needless to say, I felt frozen with fear and scared to death during. Afterwards, I felt like I was
worthless and dirty. I dropped out of the Scouts after the third abuse incident. Tilley worked
for the police department, and I was afraid to say anything to anyone in such a small town,
especially since I had reported the first abuse and was told to stay quiet—I was scared it would
only make my life miserable if I said anything else or tried to report him further.



I feel that my life would have not had so much go wrong if I had not been sexually assaulted by this Scout
leader while I was in Boy Scouts. From the time he climbed on and molested me, I have lived my life with
fear, anxiety, and insecurity. It is still painful to think about what happened and how nasty, used, dirty
and worthless I felt my entire life as a result.
My whole I have had a hard time trusting people, but particularly men in positions of power. I feel like
everyone is out to get me.
For my entire life, I held these negative feelings inside and it has eaten me up. I refused to get dressed in
school locker rooms or anywhere else that had group facilities. I still have self-esteem issues and let
people walk all over me.

I have lived my life with severe lack of trust towards others, fear of not "being a man," and forced myself
to never be alone without a woman in my life. I became obsessed with women to prove to myself that I
was "normal" and attracted to females. I would date any woman if she showed the slightest interest in
me just to ensure I wasn't without a woman in my life.
I have let myself be a victim in most of my relationships because I have low self-worth.
It is hard to explain, but I seem to attract abusive people in my life, as if I am a magnet for pain
and suffering. I have let women cheat, lie, steal, and abuse me both emotionally and physically.
The thought of anyone being close enough to me emotionally has always worried me because I fear that
they will notice my insecurities, anxiety, and the pain always eating at me.
I constantly wonder why the abuse happened to me? The abuse is so upsetting, and it enrages me to
think about.
I have lived my life scared and uncomfortable to be around men of any age. I am scared to let my guard
down. As a result, my professional career and personal life never really developed beyond superficial
levels. And I would have had a better
job and not had to struggle with life. I doubt I would have had so many issues with trust and insecurity
in relationships.
I drink alcohol to try to forget about the abuse and other worries in life. I drink to have the courage to be
around people. I drank my way through high school, then moved on to drugs.
When the guy across the hall invited me to dinner, I freaked out not knowing if it was a
just "friends thing" or if he was interested in me sexually. So I panicked. I cut off ties with everyone and
. I never looked back to find out if it was anything to worry

about. I just ran away and started drinking more.
. I did not have any problems with
actual classes or academics. I just could not be around people socially, not even as roommates.
My anxiety around men has been terrible all my life. I had very few friends, but everyone seemed to like
me. I had virtually no male friends.
I still occasionally have nightmares about the abuse. I wake up feeling trapped and smothered. This is
usually followed by several days of sleep issues until I eventually I get things suppressed enough for a few
weeks before it happens again. I live in a repeating cycle and I don't know if I will ever escape.
Finally, I also often have sexual issues when thoughts of the abuse come to mind in the middle of
intimacy and I lose interest. I blame it on blood pressure or back pain or whatever I can think of. But I
fail to satisfy my partner and remain unfinished due to thoughts riding heavy on my mind, which leaves
me feeling guilty and inadequate.

If the Sexual Abuse Survivor is a minor, the form must be signed by the survivor's parent or legal guardian or attorney. Any Sexual Abuse Survivor Proof of Claim signed by a representative or legal guardian must attach documentation establishing such person's authority to sign the claim for the Sexual Abuse Survivor.

Who Is a Sexual Abuse Survivor?

For purposes of this Sexual Abuse Survivor Proof of Claim, the term **Sexual Abuse Survivor** refers to a person who was sexually abused *before* turning eighteen (18) years of age.

Who Should File a Sexual Abuse Survivor Proof of Claim?

This Sexual Abuse Survivor Proof of Claim is only for people who were sexually abused before turning eighteen (18) years of age and where the sexual abuse (defined below) occurred on or before February 18, 2020. This Sexual Abuse Survivor Proof of Claim is the way you assert an unsecured claim against BSA seeking damages based on Scouting-related sexual abuse. Any person asserting a claim based on anything other than childhood sexual abuse should use the General Proof of Claim form (official bankruptcy form 410).

What Is Sexual Abuse?

For the purposes of this Sexual Abuse Survivor Proof of Claim, **sexual abuse** means, with respect to a child under the age of eighteen (18) at the time of the sexual abuse, sexual conduct or misconduct, sexual abuse or molestation, sexual exploitation, sexual touching, sexualized interaction, sexual comments about a person's body, or other verbal or non-verbal behaviors that facilitated, contributed to, or led up to abuse, regardless of whether or not such behavior was itself sexual or against the law, and regardless of whether the child thought the behavior was sexual abuse at the time. Sexual abuse includes behavior between a child and an adult and between a child and another child, in each instance without regard to whether such activity involved explicit force, whether such activity involved genital or other physical contact, and whether the child associated the abuse with any physical, psychological, or emotional harm. It involves behaviors including penetration or fondling of the child's body, other body-on-body contact, or non-contact, behaviors such as observing or making images of a child's naked body, showing or making pornography, or having children behave in sexual behavior as a group.

However, we engaged in fundraisers to ensure we could attend the jamboree. At the Jamboree, Hollender brought me into the showers. 

adults.
I remember I cried very easily. I was ashamed and embarrassed about the abuse. I was so angry
that I was exposed to it and that no one believed me. When I reported the abuse and the adults
and older Scouts did not take me seriously, it made me feel angry and unsafe. I constantly think
back to the abuse and constantly have guilt for what I should have done to get away. I have
experienced panic attacks and nightmares.
