The undersigned further certifies that the Court’s docket in this case has been reviewed and no answer, objection or other responsive pleading to the Application appears thereon. Pursuant to the notice of Application, objections to the Application were to be filed and served no later than September 13, 2021 at 4:00 p.m. prevailing Eastern Time.

The U.S. Trustee has requested a reduction in expenses requested in the Application in the amount of \$3,424.75. PSZJ has agreed to the reduction.

Pursuant to the *Order (I) Approving Procedures for (A) Interim Compensation and Reimbursement of Expenses of Retained Professionals and (B) Expense Reimbursement for Official Committee Members and (II) Granting Related Relief* [Docket No. 341] entered on April 6, 2020, the Debtors are authorized to pay PSZJ \$1,213,753.20, which represents 80% of the fees (\$1,517,191.50) and \$44,069.70, which represents the expenses requested in the Application minus the agreed upon reduction, for the period from May 1, 2021 through May 31, 2021, upon the filing of this Certification and without the need for entry of a Court order approving the Application.
