**FINAL DECREE CLOSING CERTAIN CASES  
AND AMENDING CAPTION OF REMAINING CASE**

Upon consideration of the *Certification of Counsel Regarding Final Decree Closing Certain Cases and Amending Caption of Remaining Case*, dated October 21, 2020 (the “**Certification of Counsel**”),<sup>1</sup> filed by Chisholm Oil and Gas Operating, LLC and its debtor affiliates, as debtors in the above-captioned chapter 11 cases (collectively, the “**Debtors**”), for entry of an order closing the Chapter 11 Cases of all the Debtors except the Remaining Debtor, all as more fully set forth in the Certification of Counsel; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated as of February 29, 2012; and this matter being a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that the relief requested is in accordance with the terms of the Confirmation Order; and after due deliberation and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED THAT**

1. The following Chapter 11 Cases shall be closed (collectively, the “**Closing Cases**”), effective as of the date hereof:

2. This Order shall be entered on the docket of each of the Debtors.

3. Entry of this Order is without prejudice to (i) the rights of any Reorganized Debtor or other party in interest to seek to reopen any of the Closing Cases for cause pursuant to section 350(b) of the Bankruptcy Code, and (ii) the right of Chisholm Oil and Gas Nominee, Inc., on behalf of any Debtor, to dispute, object to, or resolve any Claim that was filed against any of the Debtors in the Chapter 11 Cases.

4. The caption in the Chapter 11 Case of Chisholm Oil and Gas Nominee, Inc., Case No. 20-11595 (BLS), shall be amended as follows:
