**ORDER ABANDONING DEBTOR'S

On February 8, 2021, Peter J. Mastan, Chapter 7 trustee (the "Trustee") for the bankruptcy estate (the "Estate") of debtor Chineseinvestors.com, Inc. (the "Debtor") in the above-captioned chapter 7 bankruptcy case (the "Case"), filed in the United States Bankruptcy Court located at 255 E. Temple Street, Los Angeles, California 90012, before the Honorable Ernest M. Robles, United States Bankruptcy Judge, presiding, a *Notice Of Trustee's Intention To Abandon Debtor's Interest In Operations Located In The People's Republic Of China* (ECF No. 324, the "Notice"). Through the Notice, the Trustee sought to abandon the Debtor's interest in (a) its representative office located in Shanghai, China (the "Representative Office") and (b) its

1 ownership interest in the foreign enterprise known as NewCoins168.com Digital Media
2 Technology Ltd (Shanghai) (the “NewCoins Office” and, collectively with the Representative
3 Office, the “China Offices”).

4 No hearing on the Notice was requested or required.

5 The Court, having considered the Notice, more than seventeen (17) days having passed
6 since the filing and service of the Notice, no opposition to the Notice or request for hearing on
7 the Notice having been filed or received, and good cause appearing, finds and directs as follows:

8 1. The China Offices are of inconsequential value and benefit to the Estate.

9 2. The Trustee is authorized to immediately abandon the Debtor’s interest in the
10 China Offices, and the Debtor’s interests in the China Offices are deemed
11 abandoned.

12 3. Adequate notice of the Trustee’s intent to abandon the interests in the China
13 Offices was given.

14 **IT IS SO ORDERED.**


